1. The Basketball, Tennis & Badminton Courts and swimming pool are for the exclusive use of Two Serendra unit owners and tenants and their immediate dependents. For the basketball, tennis and badminton courts, reservation will be on a "first-come, first-served basis". Only playing residents can make reservations and must accompany their guests at all times. Children must be accompanied and supervised by responsible adults at all times.

2. All reservations can only be made for a maximum of *Two (2) weeks in advance*.

3. Suspended unit owners and/or residents and delinquent unit owners and their tenants shall not be allowed to use the facilities during the period of suspension or delinquency.

4. Only one (1) reservation per unit will be accommodated at a given time.

5. Maximum number of guests includes playing and non-playing guest.

6. In order to afford others an opportunity to use the facilities, a unit owner/tenant may only be allowed to reserve one (1) sports amenity at a time.

7. Proper attire is required for all players.

8. A unit owner/tenant shall be entitled to a maximum of two (2) playing dates per reservation per month.

9. Only one (1) badminton court may be booked per reservation.

10. Rough playing, vandalism or other indiscriminate behavior are not permitted.

11. Smoking, use of alcohol or controlled substances, littering or gambling within the court area is strictly prohibited.

12. Residents with paying guests are required to pay at the Payment Center prior to the use of the facilities/amenities. If the Payment Center is closed, the resident may pay at the Main Lobby Concierge. The Official Receipt may be claimed at the Payment Center the next business day.

13. I.D. cards and receipts will be checked before entry and use of any facility/amenity.

14. The maximum use of the tennis court is one (1) hour and the maximum time allotted for the Badminton and Basketball court shall be two (2) hours.

15. The Building Administration reserves the right to offer the use of court to other users if the registered resident is late by 15 minutes. No refunds are allowed but deferment of games is permitted for unused prepaid reservations.

16. The Condominium Corporation and its management reserves the right to refuse admission or deny the continued stay of any person in the amenities/facilities, including those who fail to comply with foregoing rules or who otherwise engage in disruptive or inappropriate behavior. Unit owners will be suspended for a period of One (1) Month if any untoward incident arises from any member of their team during their game and all their guests shall be banned from the District for Two (2) months for the first offense and permanently for the following offense.

17. The Condominium Corporation and its management shall not be liable for any loss or damage to property or injury to any person arising from the use of the amenities. Due care shall be exercised in the use of the facilities and properties of the Condominium Corporation. Damages to facilities and persons which occur during or in connection with the use thereof shall be for the account of the sponsoring owner/resident. The Condominium Corporation shall have the sole right to contract a third person to rectify any damage to the facilities.

18. In case of medical emergencies, the following fees shall apply for the use of ambulance for guests of non-residents:
