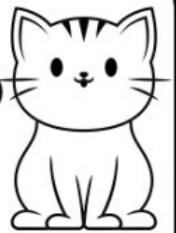

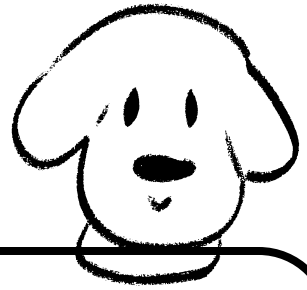

# WITH GREAT PETS COME GREAT RESPONSIBILITY



## 1. CLEAN-UP PENALTIES:

- A PENALTY OF 5,000 PESOS WILL BE IMPOSED FOR FAILURE TO CLEAN UP PET WASTE, INCLUDING NOT BAGGING POOP AND NOT WASHING PEE FROM THE GROUND.

## 2. RABIES VACCINE RESPONSIBILITY:

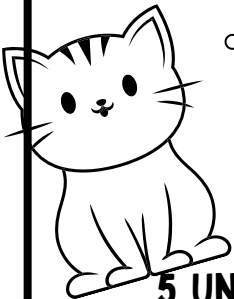
- IN THE EVENT OF A BITE INCIDENT, THE PET OWNER WILL BE RESPONSIBLE FOR COVERING THE COST OF THE RABIES VACCINE FOR THE INDIVIDUAL WHO WAS BITTEN.

## 3. MEDICAL COSTS FOR WOUND INJURIES:

- THE PET OWNER WILL BEAR THE RESPONSIBILITY OF ALL MEDICAL EXPENSES, INCLUDING NECESSARY MEDICINES AND TREATMENTS, IN THE EVENT THAT THEIR PET INFLECTS A WOUND ON ANOTHER ANIMAL OR A HUMAN.

## 4. PROPERTY DAMAGE RESPONSIBILITY:

- ANY CHEWED OR BROKEN INSTALLATIONS WITHIN THE COMMON GROUNDS CAUSED BY PETS WILL BE THE FINANCIAL RESPONSIBILITY OF THE RESPECTIVE PET OWNER FOR REPAIR OR REPLACEMENT.



## 5. UNREGISTERED PETS ARE NOT EXEMPT FROM PENALTIES FOR RULE VIOLATIONS. KEEP YOUR REGISTRATION UP-TO-DATE.

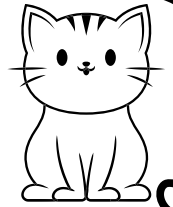

### **FUR PARENT BEHAVIOR GUIDE:**

- 1. TEACH THESE RULES TO YOUR YAYAS/PET HANDLERS.**
- 2. LEASH ON: ALWAYS USE A LEASH OUTSIDE.**
- 3. DESIGNATED AREAS: STICK TO PET ZONES AND AVOID LINGERING IN OTHER AREAS.**
- 4. CLEAN UP: PICK UP PET WASTE AND WASH THE PEE ON THE GROUND AND GRASS TO HELP THE PLANTS REGROW. DO IT INSIDE OR OUTSIDE THE PROPERTY. IT'S JUST GOOD MANNERS.**
- 5. DIAPER/STROLLER RULE: WEAR IT, RIDE IT WHEN WALKING TO A DISTANT EXIT FROM YOUR UNIT. (I.E. GATE OF ANOTHER SECTION/BLDG)**
- 6. ELEVATOR ETIQUETTE: POLITELY ASK AND GET PERMISSION FROM THE PERSON WHO'S ALREADY INSIDE.**
- 7. NOISE CONTROL: KEEP BARKING IN CHECK.**
- 8. SAFETY FIRST: EXTRA CARE AND PRUDENCE ON PETTING OR INTERACTION WITH OTHER DOGS**
- 9. RENEW REGISTRATION EVERY YEAR AND BE COUNTED.**
- 10. STAY INFORMED: KNOW COMMUNITY PET RULES AND PENALTIES.**
